Subject:- Postponement of the Examinations of the Students of Cooperative Schools.

Government Order No. 16 - Coop of 2018
D a t e d:- 03 - 04- 2018

Whereas, the Chairman, Jammu and Kashmir State Cooperative Union brought to the notice of the Government in the Cooperative Department that due to issuance of Order No: 143 of 2016 dated 14th March, 2016 by the Registrar, Cooperative Societies, J&K, purportedly aimed at streamlining of the functioning of the Centre(s) for Cooperative Management, Srinagar/Jammu and awarding of Diploma in Cooperative Management, the functioning of the State Cooperative Union has been adversely affected; and

Whereas, another meeting to review the working of the said J&K Cooperative Union was held on 22nd August, 2017 under the Chairmanship of Hon'ble Minister of State, Cooperatives; and

Whereas, in the said meeting various decisions were taken which, inter alia, include:

- i) In future, the pattern of examination shall be worked out by the Registrar in consultation with the Technical Education Department to make the course more professional and job oriented.

Whereas, the minutes nowhere make a mention about the mandate of the Cooperative Union, enshrined in the Bye-Laws of the said Union to also conduct examinations and issue Diplomas/Certificates to successful students; and

Whereas, the Registrar, Cooperative Societies, instead of opposing any move which violated the provisions of the Rules and Bye-Laws of the said Cooperative Union, acted arbitrarily and initiated the process of holding examination of the students without taking the said "Designated Authority" on board and fixed 20th March, 2018 as the date for holding the examination of the students; and


Whereas, the issue was deliberated upon in the Administrative Department and it was decided to postpone the examination and subsequently review the issues arising out of the action of the Registrar, Cooperative Societies; and

Whereas, it was further decided to conduct the examinations for the current year (Session) pursuant to Section 7 of the Bye-Laws of the J&K Cooperative Union.

NOW, THEREFORE, it is hereby ordered as under:

- (i) Withdraw Order No: 143 of 2016 dated 14:03:2016 issued by the Registrar, Cooperative Societies, ab-initio;
- (ii) The J&K State Cooperative Union shall immediately initiate the process of holding examination of the students/trainees of the Centre or Cooperative Management, Jammu/Srinagar, as provided under the Rules and Bye-Laws of the said Union; and
- (iii) Cooperative Union shall be provided adequate funds by the Registrar, Cooperative Societies, for facilitating the later to conduct hassle free examination of the students/trainees.
- (iv) The Additional Secretary to Government, Cooperative Department, shall personally monitor the process and ensure its culmination by the middle of current month.
