The appointees shall report in the Cooperative Department, Civil Secretariat Jammu/Srinagar within a period of twenty one (21) days from the date of issuance of this order and such candidate who fail to join within the stipulated time, shall forego their right to appointment and the same shall be deemed to have been cancelled **ab-initio** without any further notice.

The appointees shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:-

- i. Academic/Technical Qualification Certificates
- ii. Matriculation/Date of Birth Certificate.
- iii. Health Certificate issued by the Chief Medical Officer.
- iv. Domicile Certificate issued by the Competent Authority.
- v. Certificate from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been availed by the appointee.
- vi. Valid Category Certificate, if any applicable.

The appointment of the above candidate shall further be subject to the following conditions:-

a. Each appointee shall give an undertaking in the shape of an Affidavit to the effect that if on verification, his/her Qualification/ Date of Birth/ Reserved Category Certificates from the concerned issuing authorities is found fake/forged, his/her appointment shall be deemed to have been

- cancelled *ab-initio* and the legal action as warranted under rules shall be initiated against him/her.
- b. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth and Relevant Category Certificate is received from the concerned authorities/agency.
- c. The appointment of the candidates shall be governed in terms of Jammu & Kashmir Probationer (Condition of Service, Pay & Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O. 192 dated 17.06.2020.
- d. The inter-se-seniority of the appointees shall be determined as per the merit secured by them in the selection process as indicated against each in the select list furnished by the J&K, Public Service Commission.
- e. The appointment of the above candidates shall be subject to outcome of writ petition(s), if any, pending before any Competent Court of Law.
