- c) To improve CRAR of the Bank upto 9% a mandatory requirement under the Banking Regulation Act, 2012 failing which the Bank can be ordered to go on liquidation by Reserve Bank of India causing loss of lakhs of depositors, resulting in public outcry and embarrassment to the UT Government.
