**WHEREAS**, pursuant to the recommendations of the J&K Services Selection Board, among others, Sh. Pankaj Kumar S/o Sardhari Lal, Village Gulami Chak, Camp Gole Gujral, Jammu was appointed as Orderly in the Cooperative Department vide Government Order No. 38-JK (Coop) of 2021 dated 23.10.2021 under SC Category in Division Cadre, Kashmir.

**WHEREAS** vide Order No. 21-RCS/Adm of 2021 dated 24.11.2021, Sh. Pankaj Kumar was posted in the Office of Additional Registrar, Cooperative Societies Kashmir and the said official joined his duties on 15.12.2021 at his place of posting.

**WHEREAS**, the Additional Registrar (Hqr) has intimated that the Additional Registrar, Cooperative Societies Kashmir vide his letter No. Add//RCS/Adm/738 dated 03.01.2022 informed that the said official was continuously absconding from his duties since his joining in the Department. Accordingly, the Additional Registrar, Cooperative Societies Kashmir has served show cause notice to the said official through registered post.

**WHEREAS**, this Department vide No. Coop-Estt/41/2022 dated 17.01.2022 issued Final Show Cause Notice to Sh. Pankaj Kumar S/o Sardhari Lal, Village Gulami Chak, Camp Gole Gujral, Jammu thereby giving him an opportunity to explain his position regarding his absence from duties failing which it shall be construed that he has nothing to say in his defense and action as warranted under rules shall be initiated against him without any further delay.

**WHEREAS**, Sh. Pankaj Kumar vide his reply dated 18.01.2023 submitted that he was unable to leave the station i.e. Jammu due to some domestic problem. As such he has requested that he may either be adjusted in Jammu or accept his resignation.

**WHEREAS**, as per conditions laid by the General Administration Department no cadre /Department allocated by the appointing authority/SSB shall not be changed under any circumstances by any authority/ Department.

**WHEREAS**, the resignation tendered by the official has been examined in terms of the Jammu and Kashmir Civil Service (Classification, Control and Appeal) Rules, 1956 and found covered under the extant norms/ regulations.



**NOW THEREFORE**, the resignation tendered by Mr. Pankaj Kumar S/o Sardhari Lal, Village Gulami Chak, Camp Gole Gujral, Jammu is hereby accepted on his own request and he is discharged from the post of Orderly in the Cooperative Department with effect from 16.12.2021.
