Pursuant to the recommendations of the J&K Services Selection Board, sanction is hereby accorded to the appointment of Sh. Jahangeer Ahmad Khan S/o Habibullah Khan R/o 32 Kreshpora Nagrimalpora Kupwara as Multitasking Staff (Orderly) in the Cooperative Department under O.M category Divisional Cadre Kashmir in the Pay Level of SL-1 (14800-47100).

The appointment of the above candidate shall be subject to the following conditions:

- a. The cadre/Department allocated by appointing authority/SSB shall not be changed under any circumstances by any authority/Department.
- b. The appointment of the above appointee shall be cancelled ab-initio, if it is found that he possess higher qualification than the prescribed one at any stage and he shall also be liable for criminal prosecution under law.
- c. If, on verification, genuineness of the qualification/ category certificate from the concerned issuing authority is found fake and forged, the claim of the appointee for appointment as MTS (Orderly) shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him
- d. The appointee shall be initially on probation for a period of two years.
- e. If the appointee fails to join within a period of 21 (Twenty one) days from the date of issuance of this Order, he shall forego his right to the appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- f. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- g. The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.

Further, the appointee shall report to the Registrar Cooperative Societies, J&K within a period of twenty one (21) days from the date of issuance of this order and shall be allowed to join only on production of the following certificates (in original) to be verified subsequently:

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate from the concerned Chief Medical Officer of the District.
- iv. Domicile Certificate.
- v. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been availed by the appointee.
- vi. Valid relevant Category Certificate, if any.
- vii. The appointee shall furnish an Undertaking as per the enclosed format
