Subject: Cancellation of Appointment.

Government Order No. 01 -JK(Coop) of 2023
Dated: 12 .01.2023

Whereas, Cooperative Department vide its indent dated 19.10.2020 and 28.01.2021, referred 179 posts of Jr. Supervisor/Sub Auditor to the J&K Service Selection Board.

Whereas, The J&K Services Selection Board vide No.SSB/Sel/Secy/6279-84 dated 18.10.2022 forwarded selection list for the posts of Junior Supervisor/ Sub Auditor (Cooperative Department) to this Department

Whereas, after receiving verification reports of character and antecedents of the selected candidates from the concerned District Magistrates, appointment orders were issued in favour of 71 candidates vide Government Order No. 34-JK (Coop) of 2022 dated 29.10.2022, wherein among others, appointment order was also issued in favour of Sh. Vikrant Sharma S/o Kamal Lal Sharma R/o Peli Sunderbani Rajouri under ALC/IB category, District cadre Udhampur of the said Government Order and Sh. Nahim Ahmed S/o Basharat Hussain R/o Badhoon B Rajouri under ST category, District cadre Rajouri (figuring at S. No. 14 and 21 respectively) of the said Government Order.

Whereas, after perusal of the selection list furnished by the J&K SSB, it has been found that recommendations in favour of Sh. Vikrant Sharma and Sh. Nahim Ahmed have been kept withheld for want of some clarifications. However, due to urgency involved in the matter, the appointment orders were wrongly issued due to oversight in favour of these two candidates.

Now, therefore, Keeping in view the above, the appointment Order as Junior Supervisor/Sub-Auditor in respect of following candidates issued vide Government Order No. 34-JK(Coop) of 2022 dated 29.10.2022 under endorsement Order No. Coop-Estt/36/2022 dated 29.10.2022, is hereby cancelled ab-initio:-
